

**PENFED ELEVATION TOUR GIVEAWAY
TRIP FOR 2 TO A 2023 PENFED PARTICIPATING AIRSHOW
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND
IS NECESSARY TO ENTER OR WIN.**

- 1. ELIGIBILITY:** The PenFed Elevation Tour Giveaway (the “Giveaway”) is open only to individuals age 21 or older who are legal residents of the continental United States, or the District of Columbia (collectively the “Eligibility Area”). Employees, officers and directors of, Mike Goulian Airshows, Inc. (“Sponsor”), Shamrock Sports and Entertainment, Whelen Aerospace Technologies, Pentagon Federal Credit Union and all of their parents, affiliates, subsidiaries, advertising and promotion agencies and promotional suppliers (aforementioned individuals and organizations collectively, the “Promotion Parties”), and the immediate family members (spouse, siblings, and children, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible. Void outside of the Eligibility Area and where prohibited. All federal, state, and local laws and regulations apply.

Note that by entering this Giveaway, you are agreeing to be bound by these Official Rules and the decisions of the Sponsor which shall be final and binding on all matters relating to the Giveaway.

- 2. TIMING:** The Giveaway begins at 12:00:01 AM Eastern Time (“ET”) on April 29, 2022 and ends at 11:59 PM on November 1, 2022 (“Giveaway Period”).

TO ENTER: There are two ways to enter the Giveaway: (1) register at <http://www.mikegoulian.com/penfed> to complete and submit the online entry form, or (2) visit one of the 2022 PenFed Elevation Tour events and sign up in person at the PenFed Wall of Honor Tent. Tour locations: Fort Lauderdale [April 30 - May 1], Ocean City [June 11-12], Detroit [July 16-17], Huntington Beach [Oct 1-2] or Orlando [Oct 29-30].

Regardless of method of entry, there is a limit of one entry per person/email address. Entries will be disqualified if they are late, incomplete and/or in excess of any stated entry limit. Sponsor’s computer will be the official time clock for the Giveaway. The use of any device or technique to automate participation in this Giveaway, including but not limited to, participation using any bot, macro, script, hack, on-line Giveaway service or form-filling software (or any other devices or techniques intended to automate any part of participation in the Giveaway) is prohibited. Participation by any means which subvert the participation process as described herein will be void. Entries are void if unreadable, inaccurate, incomplete, mutilated, tampered with, forged, irregular in any way, or otherwise not in compliance with these Official Rules. If Sponsor or its designee, in its sole discretion, determines that any participant has used any device or technique to automate or subvert the participation process or participation limits, all participation by that participant will be void and future participation attempts by the participant at issue may be blocked. All submitted information becomes property of Sponsor and will not be returned. Any acknowledgment of receipt of entry does not constitute any representation as to eligibility, selection as a potential prize winner, or is it otherwise binding upon the Promotion Parties in any respect. Proof of submission of entry does not constitute proof of receipt of entry. In the event of a dispute as to the identity of the entrant associated with any entry, the authorized account holder of the email account or phone number

associated with the applicable Giveaway registration, at time of submission, will be deemed to be the entrant, as applicable. The “authorized account holder” is the natural person assigned to the applicable email account by the email service provider, or to the applicable phone number by the applicable telephone service provider. Potential winner may be required to show proof of being the authorized account holder. In the event a dispute regarding the identity of the person who actually submitted an entry cannot be resolved to Sponsor's/Administrator's satisfaction, the affected entry will be deemed ineligible. Entrants are solely responsible for internet access and usage charges incurred during participation in the Giveaway, if any. Note that free internet access is available at most public libraries. If you opt to use a wireless mobile device to submit an entry, data rates and other charges may apply; check with your mobile carrier for rates/details.

- 3. RANDOM DRAWING / PRIZE / ODDS OF WINNING:** On or about November 10, 2022, Mike Goulian Airshows, Inc. will conduct a random drawing at its offices in Plymouth, MA, from among all eligible entries received to award one (1) Grand Prize: Winner will receive 2 VIP tickets to a participating airshow event (Saturday or Sunday) in 2023, opportunity to mingle with the Goulian airshow team, 2 domestic airline tickets, and 1 night at a local hotel. Excludes: ground transportation, airline bag or seat fees, travel protection insurance, hotel incidentals, and meals (other than what is provided at the VIP ticketed area). Prize may be subject to restrictions imposed by prize sponsor. No cash value. Approximate US\$ Value: \$1,500. Winner need not be present to win.

All eligible entries have an equal chance of winning. Odds of winning will be determined by the number of eligible entries received. No prize transfer. No prize substitution except by Sponsor due to prize unavailability, safety or security considerations, or any other reason as solely determined by Sponsor in which case a prize of comparable or greater value will be awarded.

- 4. WINNER NOTIFICATION:** The potential winner will be notified by phone and/or email, at Sponsor's sole discretion. A potential winner must reply as instructed to identify him/herself, confirm his/her eligibility and ability to accept the prize, and provide his/her complete contact information within three (3) business days following attempted notification, or he/she may be disqualified, and an alternate winner selected as set forth above. Potential winner will also be required to complete an affidavit of eligibility, a liability release, and (where legal) a publicity release, which must be returned within the time period specified at the time of such request. Proof of identity, age, and legal residence may be required to claim a prize. typographical, printing or other error relating to or in connection with the Giveaway, including, without limitation, errors which may occur in the administration of the Giveaway, processing of entries; the announcement of the prizes or in any Giveaway-related materials, (b) failed, incomplete, garbled, or delayed computer transmissions; (c) late, lost, garbled, misdirected, incomplete, stolen, delayed or misdirected entries or prize claims; (d) inaccessibility of any website in whole or in part for any reason; (e) damage to entrants' or any person's computer, mobile device or other equipment or the contents thereof; or (f) any condition caused by events that may cause the Giveaway to be disrupted or corrupted. INDEMNITY:** By participating in the Giveaway, you agree to indemnify and hold the Released Parties harmless from any and all claims, damages, expenses, costs (including reasonable attorneys' fees) and liabilities (including settlements), brought or asserted by any third party against any of the Released Parties due to or arising out of your entry, or your conduct in creating an entry or otherwise in connection with your participation in this Giveaway, including but not limited to:

claims for trademark infringement; copyright infringement; violation of an individual's right of publicity or right of privacy; or defamation.

PRIVACY:** Information submitted in connection with the Giveaway (including the contact information associated with their qualifying checking account application) will be treated in accordance with these Official Rules and Sponsor's Privacy Policy (as may be amended from time to time), available via http://www.mikegoulian.com/privacy_policy, provided, that in the event of any conflict between these Official Rules and such Privacy Policy, the terms and conditions of these Official Rules shall prevail.
- 11. DISPUTES/GOVERNING LAW:** All issues and questions concerning the construction, validity, interpretation and enforceability of these rules, or the rights and obligations of any entrant or the Promotion Parties in connection with the Giveaway, shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts without giving effect to any choice of law or conflict of law rules or provisions which would cause the application or the laws of any jurisdiction other than the Commonwealth of Massachusetts. Any action or litigation concerning this Agreement shall take place exclusively in the federal or state courts sitting in Plymouth County, Massachusetts, and you expressly consent to the jurisdiction of and venue in such courts and waive all defenses of lack of jurisdiction and inconvenient forum with respect to such courts. Headings and captions are used in these Official Rules solely for convenience of reference and shall not be deemed to affect in any manner the meaning or intent of these Official Rules or any provision hereof.
